

VIP Ride Across the Golden Gate Bridge February 16, 2009
Release of Liability Waiver

In consideration of your acceptance of my entry in the VIP Ride Across the Golden Gate Bridge on February 16, 2009, of my own free will, I, for myself, my heirs, executors, administrators and personal representatives, hereby forever waive, release and give up all claims, demands, liability, damages, costs, expenses of any kind whatsoever and I agree not to sue The City of Sausalito, The Sausalito Chamber of Commerce, The Amgen Tour of California, Medalist Sports, the Anschutz Entertainment Group, the Local Organizing Committee, the Spinnaker Restaurant, the Sausalito Yacht Harbor, any sponsor, organizer, volunteer, volunteer organization, contractor, subcontractor or administrator of the VIP Ride Across the Golden Gate Bridge, the National Park Service, GGNRA, Golden Gate Bridge Highway and Transportation District, Cal Trans, California Highway Patrol or Dept. of Transportation or any elected or appointed official, officer, director, employee, representative, agent, contractor or subcontractor or of any of the foregoing with respect to any claim that may arise in connection with the VIP Ride Across the Golden Gate Bridge or any related activity or my participation therein, including any and all claims of personal injury, wrongful death or property damage. I attest that I am physically fit and sufficiently trained to participate in the VIP Ride Across the Golden Gate Bridge. I understand that the VIP Ride Across the Golden Gate Bridge is a dangerous activity. I hereby assume all risk in connection with my participation in the VIP Ride Across the Golden Gate Bridge and related activities, including traveling to or from the event, even if caused in whole or in part by the negligence or other fault of the parties or persons I am hereby releasing, by the dangerous or defective condition of any property or equipment owned, maintained, or controlled by them and/or because of their liability without fault. I fully understand I am forever giving up, in advance, any right to sue or make any claim against the parties I am releasing if I suffer such injuries and damages, even though I do not know what or how extensive those injuries and damages might be, and am voluntarily assuming the risk of such injuries and damages. I understand that in all cases, my participation fee and/or other expenses paid are non-refundable and non-transferable and only applies to the VIP Ride Across the Golden Gate Bridge. I further understand that the fee is nonrefundable if the event is cancelled due to the threat of or acts of God, war, terrorism, disaster, earthquake, government regulation and/or for economic/financial reasons. I understand that in the event I fall back from the main group of VIP riders at any time or if I am deemed to be doing, saying or showcasing something unsafe, offensive or not appropriate to race organizers and/or sponsors, the event organizers have the right to remove me from the event without refund of fees paid. I hereby consent to the use by the VIP Ride Across the Golden Gate Bridge and the Amgen Tour of California, the City of Sausalito, the Sausalito Chamber of Commerce, the Local Organizing Committee and its permittees of my name, photograph, and likeness in connection with my participation in the VIP Ride Across the Golden Gate Bridge and related activities.

In addition, if I am registering for a third party, I represent and warrant that I have been duly authorized to act as agent on behalf of such parties in performing this event registration. If the participant is a minor then I, the undersigned parent/guardian, give permission to a designated MD, American Red Cross or emergency service providers to provide the participant with medical attention in the case of an injury or medical problem while participation in the VIP Ride Across the Golden Gate Bridge and all other related events.
